PURPOSE

This Memorandum of Agreement (MOA) sets out the terms by which Department of Economic Development and Tourism and Dawid Kruiper Municipality will work together to develop the LED Strategy and implementation plan for Dawid Kruiper Municipality. DEDaT aims to support LED catalyst projects within the Municipal area to ensure that the local investment climate is functional for local businesses by rendering support.

This agreement will remain in effect from 01 July 2018 to 31 March 2019. The Director of REDS will be the key contact for the Department of Economic Development and Tourism for this project and the Director Development and Planning will be the key contact for Dawid Kruiper Municipality for this project. These individuals are responsible for ensuring the conduct of the activities listed below.

Through this agreement, Department of Economic Development and Tourism commits to review the LED strategy and Implementation plan for Dawid Kruiper Municipality.

2. ROLES AND RESPONSIBILITIES

2.1. Responsibilities of Department of Economic and Tourism

- a. Assign a dedicated team for research and development of the Strategy.
- b. DEDaT to assist Dawid Kruiper Municipality with Statistical data.
- c. Prepare documents as per inception report:
 - Statistics,
 - Opportunity profile,
 - LED framework,
 - LED Strategy,
 - Implementation,
 - Provide the Municipality with one electronic copy of the LED Strategy,
 - Provide the Municipality with one hard copy of the LED Strategy.

2.2. Responsibilities of Dawid Kruiper Municipality

- a. Allow for Cooperation and access to information (source documents) required for development of the strategy.
- b. Dedicated team members for access to information and ensure skills transfer.
- c. Consider and adopt the following:
 - Inception report,
 - Draft LED strategy,
 - Proposed LED strategy,
 - Implementation plan,
 - Arrange, Coordinate and provide venue for stakeholder consultation as per agreement
 - Documents for council, officials and community to be prepared by the municipality.

3.3 Project Teams

- II. Working team, which consist of:
 - a) Assistant Director: REDS, ZF Mgcawu District
 - b) Director Development and Planning
 - c) LED Manager and IDP Manager
 - d) LED Officer and IDP Officer
 - e) LED Administrator and IDP Administrator

From the Department's side the Project Leader will be the Director REDS and the Project Manager will be the Assistant Director: REDS, ZF Mgcawu District. It is recommended that the Municipality also assign a Project Leader and Manager.

3.4 Order of meetings

The Working Committee meetings shall be conducted on a weekly basis and the Management Committee meetings on a monthly basis. The meeting will be chaired by the Local Municipality on both committees.


4. DURATION OF THE AGREEMENT

This agreement will be in effect from **01 July 2018** till **31 March 2019** and may be updated at any time through written agreement of each partner. Either party can terminate the agreement with 30 days written notice.

TERMS AND CONDITIONS.

It is mutually understood and agreed by and between the parties that:

5.1. Each party takes legal and financial responsibility for the actions of its respective employees, officers, agents, representatives and volunteers. Each party agrees to indemnify, defend and



hold harmless the other to the fullest extent permitted by law from and against any and all demands, claims, actions, liabilities, losses, damages, and costs, including reasonable attorney's fees, arising out of or resulting from the indemnifying party's acts or omissions related to its participation under this Memorandum of Agreement, and each party shall bear the proportionate cost of any damages attributable to the fault of such party, its officers, agents, employees and independent contractors. It is the intention of the parties that, where fault is determined to have been contributory, principles of comparative fault will be applied.

- 5.2. Each party, at its sole cost and expense, shall carry insurance or self-insure to cover its activities in connection with this MOA, and obtain, keep in force and maintain, insurance or equivalent programs of self-insurance, for general liability, workers' compensation and business automobile liability adequate to cover its potential liabilities hereunder.
- 5.3. This MOA may be amended from time to time by mutual agreement of the parties in a written modification signed by both parties.
- 5.4. This MOA may be terminated by mutual agreement of the parties, and shall automatically terminate upon completion of all responsibilities as stated herein, unless otherwise amended.
