NOTICE IS FURTHER GIVEN in accordance with Section 21A of the Local Government Municipal Systems Act, No. 32 of 2000 that –

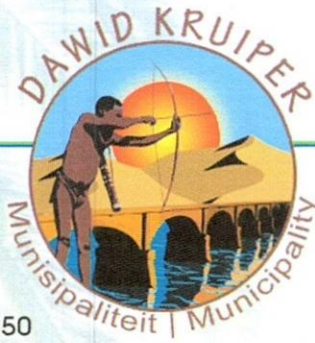
