### 1. PURPOSE AND OBJECTIVE

This document serves to outline Dawid Kruiper Local Municipality risk management activities that will be carried out in the 2023/2024 financial year. The risk management implementation plan for the Local Municipality is hereby prepared to give effect to the implementation of the risk management policy and strategy and to sets out all risk management activities planned. Furthermore, the risk management implementation plan includes mSCOA as well as the implementation of fraud risk.

### 2. BACKGROUND

The implementation of Risk Management activities and practices resides with the Municipal Manager who has further delegated the function to the Manager Risk Management.

For further capacity building in areas of Risk management as well as implementation of risk management practices for the next financial year, partnership with Provincial Treasury has been established.

#### 2.1 Challenges

The main challenge is the capacity constraints in both human resources and skills with regard to risk management.
